1. Approve Agenda

2. Appointment of Officers

- The terms for Officers is two years, Garrett Tomlinson (Government Co-Chair) and Anthony Traverse (Secretary/Treasurer) are both half-way through their terms. Doug Dallyn's (Community Co-Chair) term is expired and we have a vacancy for the position of Industry Co-Chair.
- Garrett Tomlinson has agreed to continue his role as Government Co-Chair.
- Doug Dallyn indicated he does not wish to continue as Community Co-Chair.
- Anthony Traverse indicated he wishes to step into the role of Industry Co-Chair.
- Reid Glenn indicated he would be interested in the role of Community Co-Chair.
- Shelly Shannon indicated she would be interested in the role of Secretary/Treasurer.
- Karla Reesor called for other nominations from the floor; none were forthcoming.
- Anthony Traverse was acclaimed as Industry Co-Chair; Reid Glenn was acclaimed as Community Co-Chair and Shelly Shannon was acclaimed as Secretary/Treasurer.

Strategic Planning

3. PRAMP's Current Environment

Mike presented information on adjacent areas to our boundaries. This information, along with the 5 year monitoring plan from AEP provides an opportunity for planning.

Opportunities

- Working with high school students on science programs
- Those going into IT tech programs post secondary, gives exposure to air science
- Career/job opportunities, mentorship
- Three and five year planning that AEP is doing, trying to provide coverage in the identified gaps.
- High level
- AH would be willing to entertain funding if a proposal for human health risk assessment is provided; or public education on air quality (smaller request to support outreach)
- AQHI station
- Focus studies/business case for purchasing equipment from AEP
- Rent to own option with Maxxam

- Expanding the boundaries and ask for membership fees
- Potential for PRAMP to do the monitoring in the north (High Level area) where AEP has identified gaps and would be interested in smaller units such as an air pointer

Challenges

- Trying to will the gaps identified in the 5 year plan
- Need diversification and reverse of funds
- Maxaam is very far away
- Local staff to do passive and canisters

Boundaries

- High Level – industry in that area
- Would need to look for other sources of funding as it is not part of OSM
- Look at production data and emissions and existing monitoring
- Partnering opportunities
- With water groups – i.e. Mighty Peace Water Coalition
- Consider a baseline data station
- Currently TOR contemplate the boundaries could change but does not restrict to OSM only.
