# 2. Monitoring and Reporting

### Goal:

1. Evidence-driven verification that air quality in the Peace River area is at acceptable levels and that emissions are being minimized.

### 2.1 PRAMP Data Reports

- The Dashboard Reports have been posted to the website. *https://prampairshed.ca/air-monitoring/monitoring-reports/dashboard-reports/*
- October no major operational issues recorded;
  - AQHI station PM exceedances caused by wildfires
  - Reno failure of barometric pressure gauge; replaced
  - PRC station SO2 analyzer failed; nine hours of downtime recorded
  - One non-methane hydro-carbon canister event at Reno on October 8th
- November
  - 986 uptime for TRS was 79%. Issue likely due to scrubber material. Total 178 hours of downtime recorded.
  - 842 all parameters met 90% uptime except the TRS analyzer; uptime was 89.4%. Like 986, something wrong with the scrubber material. 70 hours downtime were recorded.
  - Reno station was relocated November 22 and name changed to RenoB. All analyzers and systems were brought back on line on November 23.
  - AQHI one 24 hour PM2.5 exceedance was recorded due to stagnant air conditions.
  - Stagnant air conditions were seen across the province
  - No canister events recorded in November
- December
  - no major operational issues were recorded
  - The TRS and H2S analysers for all stations were all outside the span drift range because of low ambient temperatures
  - Remained in compliance with AMD performance criteria
  - New batch of scrubber material replaced in all stations
  - 986 hydrocarbon analyzer starting having issues. One hour of data was discarded
  - No canister events recorded in December

### 2.2 AQHI Station Move

- November 2023 the portable monitoring station will have been in Grimshaw for two years so we will be starting the site selection and process for identifying a new location.
- We have a policy in place for the process we use to determine a location and the process is initiated by the Technical Working Group.

### 3.2 Alberta Airsheds Council Initiatives

- Karla provided an overview of the Airsheds Council.
- The AAC publishes a provincial Air Quality Report every year.
- Plans to hold a conference in 2024.
- Innovative Air Education Program Grant from EPA in the amount of \$300K targeted to reduce non-point source emissions, particularly transportation emissions.
- Received a letter from Minister Savage providing some valuable information on upcoming grants. She indicated that the grants would be multi-year and there would be an increase for inflation. She acknowledged and appreciates the work of the Airsheds.

### 4.3 Operating Plan

- The operating plan has been posted to the Members' Portal. It is an evergreen document.
- Expect communications and outreach to increase with the return of more in person events.
- Karla will be meeting with Municipal Councils

### 4.4 Revenue Options

- Operation funding from Oil Sands Monitoring Program; Communications and Education from grant
- In discussion with Directors all indicated that establishing a reserve would be prudent but also challenging
- Some options
  - Negotiate with GOA to establish a reserve/contingency fund (similar to the business case for the capital acquisition program). We could explore with our accountant, staff and EPA staff
  - Membership fees could be scaled for emitters who do not pay into OSM
  - Sponsorship programs, although they would not provide a consistent revenue stream
  - Fundraising events such as webinars, community events
- Next steps, there may be ways to explore the feasibility of trying to establish a reserve fund through OSM or EPA without it being a formal process.

Motion for staff to investigate the four revenue options presented in the sequence priority order by Krista Park. No blocks.

### 5 New Business

### 5.1 Air Monitoring for Mercer

- We heard from Mercer recently that they would like to move forward with PRAMP taking over the operations of the stations on April 1. There were discussions on which stations (in town and the station on site) and costs.
- There are steps that need to happen before we can assume operations of the Mercer stations.
  - We need to confirm EPA's air monitoring expectations are for Mercer. We do not know what will be in the approval and it is unlikely that it will be completed by April 1.
  - We need to confirm EPA's financial support for an AQHI station in the Town of Peace River, that is unlikely to be confirmed until the fall of 2023.
  - We need to negotiate a fee for service with Mercer
- PRAMP Executive have indicated that we will have a policy for Negotiated Fee for Service Agreements.

# Motion to inform Mercer that confirmation of EPA's monitoring expectations and financial commitment to an AQHI station is needed before PRAMP can move forward on a fee for service agreement with Mercer by Jason Javos. No blocks

- Question on equipment owned by Mercer. If the equipment is turned over to PRAMP what does that mean? Mercer has indicated that they want to turn the equipment over to PRAMP. Part of the operating agreement would need to include equipment repairs and upgrades.
- Recommendation that the policy be the same as CNRL.

### 5.2 NAIT Project

• Kevin Kembell has made a connection with the NAIT Industry Solutions to look at a Capstone Project for PRAMP to sponsor.
